This past week I had the pleasure of speaking to the incoming class of Department of the Navy Financial Management Career Program (FMCP) trainees. FMCP trainees are recent college grads who begin a two-year program of rotational assignments inside financial management offices all over the Department of the Navy and the Department of Defense.

In 1989 I came into the government as a Presidential Management Intern and it is exciting to see that three decades later young people are still eager to launch their financial management careers that will meaningfully improve the way we do business in the DoD.

As usual I took the opportunity to describe to this group all of the changes that are underway in the Financial Management world. One of the things that struck me was how far we have come in the last three decades. Early in my career one of the biggest challenges was explaining to folks in the office what a mouse was for, how spreadsheets automatically summed up a column of numbers, and what you could do with a web browser.

As a budget analyst I was always interested in getting my hands on actual execution information to better understand what things actually cost. I started puttering around with the PC-based software applications like Excel, and Access and started to experiment with pulling in execution information to help with my budget analyses. In the 1990s it was up to individuals with something of a hacker mentality, to figure out how to invent and use computer-based tools and then show their co-workers ways to conduct useful analyses using them.

Fast forward 30 years and everyone is interested in harnessing the power of "big" data to help leaders across the DoD make better decisions about spending money. I told this new class of financial management trainees how lucky they were to be entering the government at this moment. I reminded them that the CFO act of 1990 was older than most of them but that in all likelihood, early in their careers, they would see the Department of the Navy and the DoD finally get an unmodified audit opinion on our financial statements. I reminded them that at that point, sustaining auditability and using the new systems and processes that we all have been developing over the last few decades to make better decisions was going to be their job.

Stay Connected!

I'd like to thank Mr. Brian Wood from the Marine Corps for speaking to the Washington Chapter last month. Mr. Wood presented a compelling case for how audit is really an operational imperative. His talk reminded us all that that audit is a whole team effort and that it is possible to have productive conversations with the "Operators" that convinces them that if we do this right, cleaning up our financial business can actually deliver more capability to the warfighters. I look forward to seeing you all at our next monthly meeting where we can continue the conversation.

"Anticipating Long-Overdue Innovation"

He is responsible for accurately capturing requirements related to the Air Force Budget Formulation process and working collaboratively with the Program Management Office (PMO) to ensure those requirements yield an acceptable target system.

Do you recall the anticipation of getting your very first smartphone? How you longed for the device that would simplify your life and expand your realm of possibilities? Air Force financial professionals who attended this year's American Society of Military Comptrollers Professional Development Institute experienced that feeling as they participated in the Program & Budget Enterprise System (PBES) workshop which provided a glimpse of what's to come.

Already used within the Defense Agencies Initiative, Navy Military Sealift Command, and Army Corps of Engineers, PBES is a proven COTS budget formulation system selected to replace the Automated Budget Interactive Data Environment System (ABIDES). Although ABIDES served the Air Force well for more than 50 years, its replacement is long overdue. Originally constructed as a modified database in the late 1960s and later coded in C-language as a full-blown system, ABIDES does not possess the robust features of today's modern business systems. For example, although ABIDES was hard-coded with a rigid reporting function, it pales in comparison to today's dynamic business intelligence tools which afford ...*continued next page*

Continued....users the flexibility to pull data from a system any way they wish to see it. In addition to its inflexible nature, ABIDES lacks the functionality to integrate "planning" in the overall Planning, Programming, Budgeting, and Execution (PPBE) process—something the Air Force aims to correct with PBES. In fact, PBES is charged with integrating the planning, programming, and budget processes within a single system. As a result, PBES will subsume the individual systems which support the planning, programming, and budget processes—saving the Air Force crucial budget dollars while gaining incredible efficiencies.

Attendees at the workshop listened intently as they learned that PBES consists of three separate Oracle commercial off-theshelf products. Each of these products is currently being configured. The three Oracle products, Hyperion, Data Relationship Management (DRM), and Business Intelligence (BI) manage specific functions within PBES. This powerful analytical tool provides users with self-service dynamic reporting and defined dashboards powered by a comprehensive data warehouse. Therefore, PBES users will be able to extract and analyze data in any way imaginable. In addition, managers will enjoy the established dashboard analytics which will promote expedient decision support.



As workshop attendees sat eagerly wondering when this innovative system would become available, the PBES program manager, Mr. Jason Hanson, reviewed the system roll-out timeline. According to the latest schedule, PBES will deploy to the major commands first—this fall—followed shortly thereafter to the Air Staff in early winter. "Ultimately," Mr. Hanson stated, "our plan is to get PBES out to the field so that it can be used for the FY21 Program Objective Memorandum and FY22 planning cycles."

Along with the timeline review, Mr. Hanson made sure to stress the importance of PBES user training. He indicated that as part of the deployment activities, the system's integrator will provide varying forms of detailed training to all PBES users. Every PBES stakeholder understands how essential quality training is to the system's success. Thus, PBES has an entire team dedicated to ensuring the training products being developed promote an intuitive, comprehensible format.

As the workshop came to a close, Mr. Hanson made a point to address the difference between a system's "functionality" versus a user's "desire." He cautioned future PBES users that although the system may function appropriately, its configuration may not reflect their desired preferences at this point. Therefore, he asked for patience and understanding as the system will no doubt evolve over time, given user feedback.

Regardless of personal preferences, PBES will provide its users with a technological and functional quantum leap forward. Just like that very first smartphone we were all so anxious to get our hands on, PBES will probably take some time getting used to as well. Once we do, we will never know how we were able to live so long without it.

Mr. Craig Bennett, a member of the Senior Executive Service, is the Deputy Assistant Commandant for Resources and Deputy Chief Financial Officer for the United States Coast Guard. He is the principal advisor to the Assistant Commandant for Resources/Chief Financial Officer and senior staff for all budgetary and financial management matters, and serves as the Coast Guard's Chief Risk Officer. As our September luncheon guest speaker, Mr. Bennett shared an informative overview of the U.S. Coast Guards management control program. Mr. Bennett stated that the Coast Guard is currently implementing the Enterprise Risk Management (ERM) requirements outlined in OMB Circular A-123 "Managements Responsibility for Enterprise Risk Management and Internal Controls", and the development of an enterprise risk register to support strategic planning and resource management governance. Mr. Bennett's thought provoking discussion on the Coast Guard's efforts to better identify and document risks helped shed light on a very unique subject. In all, the Coast Guard has identified over 350 risks that could have a detrimental impact on the Coast Guard's financial resources. From natural disasters to maritime terrorist events, Mr. Bennett discussed the process by which the Coast Guard has engaged its regional commanders to identify risks in their area of responsibility for review and incorporation into the Coast Guards risk register.



While most candidates in the CDFM program are civilian or military/reserve members of the Department of Defense, U.S. Coast Guard, U.S. Army, U.S. Air Force, U.S. Navy, U.S. Marine Corps or employees of defense contractors or suppliers, the CDFM program is open to <u>all candidates</u> who have a high school diploma (or equivalent) and meet the following work experience qualifications:

Have the required number of years of defense-related financial management experience outlined below:

- Two (2) years if you hold an Associate's degree or higher; or
- Three (3) years if you do not have a degree. OR

Do not have defense-related financial management experience, but can meet the following criteria outlined below:

- Four (4) years of Federal government-related financial management experience; and
- An Associate's degree or higher.

There are three steps involved with earning your CDFM:

<u>1. Enroll in the CDFM Program</u>. Your enrollment is valid for two (2) years, during which time you must take, and successfully pass, the three CDFM module examinations.

2. Submit Your Verification of Financial Management Experience Form. This form, which must be signed by a supervisor who can verify your work experience, must be returned to ASMC after enrolling in the CDFM program. You do not have to submit this form prior to taking a CDFM examination, but it is <u>required</u> prior to the awarding of the CDFM designation.

<u>3. Purchase and Schedule the CDFM Examinations</u>. Be sure to carefully – and completely – read the criteria associated with each testing option for the CDFM examinations. Failure to do so can result in the purchase of the wrong CDFM examination and/or the inability to test at your preferred location
