- Applies a wide range of standard practices and procedures to phases of financial administrative processes. Research regulatory material to obtain factual information. Applies a wide range of analytical techniques to search results. Work contributes to the cost-effective use of funds to assure funds are not over or under obligated and are spent in a timely manner.
- Requires comprehensive, detailed knowledge and understanding of budgetary polices, precedents, procedures, and regulations. Detailed intensive knowledge of policies, precedents, goals, objective, regulations, and guidelines of a functional area. Intensive knowledge of administrative and financial management systems, to include DAI, WAWF, SMARTS, and DCAS. Skill in identifying, analyzing, and resolving a range of budgetary problems such as development of alternative methods of funding; formulation of budget estimates for program in which funding requirements have changed significantly. A high degree of skill in analytical reasoning, ability to apply skill to the identification, analysis and conceptualization of budgetary problems and development of alternative solution is required.
- Serves as the Lead Defense Travel Administrator for the marine Corps Logistics Base Albany Command.
- Operates with a high degree of independence in carrying out financial management responsibilities and assists junior analysts as needed.
